Government Leading by Example

OEMR is accepting applications from rural cities and counties that want to save money by reducing their energy costs in existing public buildings. Approved applicants receive an energy audit and may qualify for cost-share funding on energy efficient retrofits.

Energy Resilience Grant Program

ERGP fosters strategic investments that demonstrate measurable improvements to grid resiliency, deliver modernized grid infrastructure, and mitigate risks from increased electrification and disruptive events. Funding is available to electric grid operators, electricity storage operators, electricity generators, transmission owners and operators, distribution providers, and fuel suppliers. Link

Reaching a New Energy Sciences Workforce

The U.S. Department of Energy's Office of Science (SC) is announcing that \$50 million is available to build foundations for SC research through traineeships at academic institutions that have been historically underrepresented in the SC portfolio. The Reaching a New Energy Sciences Workforce (RENEW) initiative supports traineeships for students and postdoctoral researchers from non-R1 emerging research institutions and non-R1 minority serving institutions in areas relevant to SC programs. SC seeks applications to develop traineeships for participants from these institutions that involve conducting research in partnership with a DOE-affiliated institution, including DOE National Laboratories, SC user facilities, Bioenergy Research Centers, or DOE Isotope Program Production Sites. Submission deadline for Pre-Applications: 4/30/2024. Submission deadline for Full Applications: 7/23/2024. Link

Hydroelectric Production Incentives

The Hydroelectric Production Incentive Program was authorized by Congress through Section 242 of the Energy Policy Act of 2005. The program, led by the U.S Department of Energy, provides incentive payments to qualified hydroelectric facilities for electricity generated and sold. The Hydroelectric Production Incentives provide payments for energy generated and sold during a calendar year at qualified facilities that either added generation equipment to dams and other water infrastructure or are constructed in an area with inadequate electric service. This application period is for electricity generated and sold in 2023. Submission deadline for Full Applications: 4/23/2024. Link

Funding for Accelerated Inclusive Research (FAIR)

The FAIR initiative supports mutually beneficial relationships between MSIs or ERIs and partnering institutions, including DOE national laboratories, Office of Science scientific user facilities, and other MSIs. FAIR will fund basic research in all fields supported by the Office of Science, including applied mathematics, biology, chemistry, computer science, engineering, geoscience, isotope research, materials science, and physics. This funding will expand the talent pool that will further DOE missions, transform our understanding of nature, and catalyze scientific discoveries that can lead to technical breakthroughs. Submission deadline for Pre-Application responses: 5/28/2024. Submission Deadline for full applications: 7/16/2024. Link
