Energy efficiency window replacements would be an eligible weatherization project under the FIXR Program. If the building is 45 years or older, additional requirements may apply due to historical preservation requirements. See "Idaho SHPO Programmatic Agreement," appendices A and B. 2	10/7/2025	Is window tinting an eligible activity?	Generally, yes. Window tinting is an eligible weatherization project. If the building is 45 years or older, the tint must be placed "in a manner that does not harm or obscure historic windows or trim." See "Idaho SHPO Programmatic Agreement," Appendix A, section 5. 3	10/8/2025	Is onsite renewable generation (i.e., solar panels) eligible?	No, onsite renewable generation is not an eligible project.	Award Information, section C	10/28/2025
4		Can the FIXR Program fund projects with total project costs over \$100,000?	No, total FIXR Program project costs may not exceed \$100,000. Applicants may not provide cost share. 7	10/16/2025	Is installation of new electrical panels considered an eligible project?	Generally yes, installation of new energy efficient electrical panels is considered eligible. The project must increase energy efficiency and meet local building codes or the International Building Code where applicable. The project must be installed in or located on existing buildings, not remove or trim any trees, and be appropriately sized. If the project building is 45 years or older, the project must not be visible from the public right of way; no structural alterations are made; no demolition of walls, ceilings for floors occurs; no drop ceilings are added; and no walls are leveled with furring or moved. If the project involves the aforementioned actions, permanently changes the appearance of the interior or exterior of the building, or requires historic preservation analysis, the project is not eligible.		10/28/2025
8	10/16/2025	Is program funding available for any city-owned buildings or structures?	Yes, as long as the city owns, not rents, the project buildings. Note that additional project limitations may apply if the building is 45 years or older due to historic preservation requirements (see "Idaho SHPO Programmatic Agreement").
